Exploring Reconciliation through Clean Energy in Indigenous Communities with Dr. Diana Lewis and Dr. Heather Castleden

Dr. Diana Lewis (Western University) and **Dr. Heather Castleden** (University of Victoria, previously Queen's University) are are Co-Directors of *A Shared Future: Achieving Strength, Health,* and *Autonomy through Renewable Energy Development for the Future,* an international research program which explores how Indigenous knowledge systems, as applied to renewable energy development, may have the potential to lead us towards 'healthful environments' through reconciling and healing our relations with each other as well as with the land, air, and water around us. On this episode of the Porcupine, Drs. Lewis and Castleden consider what happens when industry fails to build respectful relationships and commit to meaningful consultation, and the clear relationship between reconciliation and good energy.

Dr. Chad Walker (Dalhousie University) has built upon his PhD in health geography to become an interdisciplinary environmental social scientist with interest around justice, equity, and public support for low-carbon transitions.
