#### 3. Announcements

- a. Memorials a moment of silence was observed while the names of the deceased were displayed.
- b. Undergraduate Awards the award winners, identified by departments, were announced. They receive a complimentary 1-year membership to the CAG in 2020. Congratulations to all winners, and thank you to all the departments who submitted candidates.

### **REPORTS**

4. The Canadian Geographer (TCG) - Editor's Report\*

Nadine Schuurman reviewed her report. She recapped the new design, workflow and online-only format of the journal, and stated that her top priority is maintaining the reputation of the journal. She clarified that the new contract with Wiley (as of January 2018) allows for the publication of two Freely Available (FA) articles per year, which is not the same as Open Access (OA), as well as several other articles that can

be designated FA for a period of 6 weeks. Nadine reminded the membership that TCG is no longer eligible for the SSHRC grant, which is now only available to fully OA journals. The 2017 Impact Factor was 1.477; the Impact Factor for 2018 is not yet available. Nadine highlighted some of the stats, including the top-cited papers of 2018, of the last 5 years, and of all time, as well as main download sources.

# 5. Officers' Reports:

- a. Secretary-Treasurer's Report
  - i. Financial Statements 2018

Joe Leydon reviewed the Financial Statements and reported that the Association is in a strong financial position. He explained that the deficit in 2018 was much lower than originally projected at the AGM last year in Quebec City. The membership revenues decreased in 2018, which was expected due to the arrangement that registration to the joint IGU-CAG-NCGE meeting would include CAG membership, but they were still higher than predicted. He explained the major differences between 2017 and 2018, which are largely due to categorization changes between KPMG in 2017 and the new auditors, Andrews & Co., hired in 2018, expenses relating to the IGU-CAG-NCGE meeting, and to supports now provided by the central CAG office (such as event registration services to Regional Divisions and Study Groups).

iii. Increase in the per diem for executive attendance at the Annual General Meeting The current per diem of \$70 for up to five days to cover costs associated with attendance at required business meetings of the executive (accommodation and registration not covered) is insufficient, acting as an impediment to attracting members to the executive and excluding those without access to research funding.

The motion to increase the per diem to \$150 for 3 days was amended to cover up to 5 days following a friendly amendment from the floor.

v. Increase to the conference levy

The conference levy has not been increased in many years. The levy is applied to all registrants at the conference and paid to the CAG by the LOC; it is the only guaranteed source of revenue from the conference. The proposed increase is \$5 in each category. The increased levy should not lead to higher registration fees, as the CAG is now providing additional support to the LOC (e.g., registration software, translation).

Councillor Matt Farish summarized the intent behind the statement, which will be publicly available on the CAG website and possibly in other areas, such as on conference websites and registration platforms. The document in its current form has been endorsed unanimously by the CAG Executive Committee. It is a living document and feedback is welcomed from the CAG membership.
