3. Announcements

- a. Memorials a moment of silence was observed while the names of the deceased were displayed.
- b. Undergraduate Awards the award winners, identified by departments, were announced. They receive a complimentary 1-year membership to the CAG in 2021. Congratulations to all winners, and thank you to all the departments who submitted candidates.
- c. CAG 2020 Awards the recipients of the CAG 2020 awards were announced. Thank you to all who nominated a colleague for a CAG Award, all nominees were deserving of recognition. In some award categories, nominees are retained for an additional two years after first nomination.

REPORTS

4. The Canadian Geographer (TCG) – Editor's Report*

Nadine Schuurman presented the *TCG* Editor's Report, highlighting that *TCG* is in a strong position. The difficulty in finding reviewers continues. The team is aiming to get the time from submission to original decision down to under 60 days. Nadine shared that the 2018 Impact Factor (IF) is 1.141; the 2019 IF will be available in June. She presented the papers with the most citations and shared that 50-60% of papers have never been cited. Increasing citations will improve the IF. Downloads are increasing, which impacts the revenue stream from Wiley. Nadine invited those who have access to funds to publish Open Access (OA) papers, as OA papers lead to higher downloads. She also explained that *TCG* can designate two papers as Freely Available (FA) per year, and that all papers released in the first issue of each year are FA for that year. Nadine confirmed that all submissions, regardless of where they come from, are given equal consideration and attention, as long as they are related to geography.

- 5. Officers' Reports:
 - a. Secretary-Treasurer's Report i. Financial Statements 2019*

Joe Leydon presented the Financial Statements for 2019. He explained that the qualified opinion in the audit related to CAG regional division and study groups funds. The financial statements submitted by the divisions and study groups in the absence of supporting bank statements were deemed insufficient by the auditors to render an unqualified opinion. Due to COVID-19 pandemic restrictions, division and study group treasurers were unable to access the necessary documentation. The qualified opinion refers only to these funds; the auditors expressed no concerns relating to the financial reporting of the CAG. The presentation of the treasurer focused only on the CAG central operations.

Joe explained the expenses and revenues in 2019 compared to 2018. The membership revenue has recovered in 2019 compared to 2018. *TCG* is no longer eligible for the SSHRC Grant because it is not an Open Access journal. Travel expenses were significantly higher in 2018 due to the IGU, with more funds set aside for student support and executive travel for conference planning. Travel expenses returned to normal in 2019. The office expenses cover everything required to run the central office: salary, rent, liability insurance, website fees, membership management software, etc. The association recorded a small deficit in 2018, and returned a small surplus in 2019. Joe also noted that the CAG's investments remain stable and that losses incurred in March due to the COVID-19 pandemic were recovered in April.

Joe highlighted the projected revenues, expenses, and surplus for 2020. He has recommended that rather than allocating the surplus now, we hold off given the uncertain economic climate.

First, that the membership numbers have increased in 2019 after the record low in 2018 (due to the IGU meeting registration including CAG membership that year). Second, that the issues of equity and diversity brought forward in 2019 led to the creation
