

OBJECTIVES

General:

To promote a meaningful dialogue between, Operations and civil society, expanding knowledge about disputes over land and sea domains, their mineral and biological resources, which tend to fuel conflicts and geopolitical tensions on multiple geographic scales, involving different actors and leading nations to claim borders, generating territorial conflicts with processes of dispossession and deterritorialization of the most vulnerable populations.

Specific:

- Analyze the risks associated with climate change, from a temporal perspective, from the past to the future, as well as a spatial perspective, from the global to the local;
- Discuss Geopolitical Risks in the face of territorial conflicts due to security issues and/or competition for resources, their local and global impacts;
- Explore the phenomenon of Globalization without Borders, territorial conflicts, cultural identities, social inequality and health;
- Medical Intervention in Emergency and Disaster Situations. The importance of Disaster Medicine in the provision of multipurpose care in multi-victim scenarios;
- Focus on Vulnerable Populations in the face of the risks of dispossession and deterritorialization. Social vulnerability and resilience: Concepts and challenges;
- Strengthen socio-environmental resilience through rehabilitation, recovery and reconstruction processes;
- Debate risk communication strategies, as well as educational dynamics and practices, and also other public awareness actions, with a view to promoting active citizenship in disaster risk reduction.

PRESENTATION

All over the world and in an almost daily context, more frequently and intensely, we are confronted with situations of conflicts and catastrophes, be these environmental, military clashes, epidemic outbreaks or pandemics, contamination or scarcity of resources, which jeopardize the survival and daily lives of populations, destroy communities or affect their infrastructures and cause serious social and psychological trauma.

The rapid economic growth, the globalized society, the urbanization of increasingly extensive areas, aggravated by climate change, put an increasing pressure on the territories, which together with the demographic increase or the strong migratory movements, "free" in search of better living conditions or "forced" by environmental catastrophes, promote the depilation of natural resources and the destruction of ecological niches, responsible for the Man-Nature balance, among others for filtering the air and thus containing possible viruses, and increasing exposure to different risks and, consequently, the vulnerability of populations.

Due to a diverse set of factors, which must be framed in time and space, conflicts of interest exist and are normal. On the one hand, resources are finite and, on the other hand, value systems and perceptions of reality by different actors may not coincide.

In this way, the cartography of disputes over the control of a place, a path or a relevant geographical position, or strategic assets such as water, soil, forests, minerals or various energy sources, is extensive.

In multiple contexts and different geographic scales, these conflicts are crossed by asymmetrical power relations and by dynamics of dispossession and deterritorialization, especially on the part of the most vulnerable populations.

In this interdisciplinary domain, fields such as political ecology, local geopolitics, critical and social cartography and territorial justice intersect.

In this way, between competition and the necessary cooperation between the actors, it is important to problematize the origin and anticipate these situations of conflict, as well as to discuss and analyze the management of the crises that may result from this.

GENERAL PROGRAMME

Day 23rd of May will be dedicated to the welcome and opening conference.

The days 24th and 25th of May will be devoted to scientific activities at the University of Coimbra, which will include the presentation of communications (oral and poster) and the holding of conferences.

The day 26th of May will be occupied with field work (study visits), which will make it possible to observe the consequences of the full manifestations of risks.

ABSTRACTS

The official languages of the congress are Portuguese, Spanish, French and English. There will be no simultaneous translation.
